# **Faculty Audits**

### **Faculty Audit Rates**

Current, active Faculty members enjoy at 50% reduction on course audits.

### Prerequisites to earn the Faculty rate:

- Teach annually (once every 12 months)
- NEW (per Faye): Serve on a Monthly Meeting panel at least once a year
- Attend annual Leadership Development session
- Attend Level 6 Teachers Conference annually
- Ensure power transference qualification is up to date
- Financially current with Academy

If your teaching lapses (not teaching during a one year period), you pay regular audit fees until such time as you teach again.

# **Information & Policies**

### Cancellations

In Town Courses: Refunds are issued less a \$50 administration fee up to 7 days prior to course start date. Within 7 days of course start date, no refunds will be issued except under emergency situations approved by the Academy.

Out of town courses: Refunds are issued less a \$50 administration fee up to 30 days prior to course start date. Within 30 days of course start date, no refunds will be issued except under emergency situations approved by the Academy.

If course is cancelled by the Academy, students receive a full refund.

No full or partial refunds for partially finished courses (in town and out of town courses).
