Covid/Acts of God

In March 2020, the novel coronavirus, COVID-19, was declared a worldwide pandemic by the World Health Organization. By submitting this Registration Form, applicants voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to themselves (including, but not limited to, personal injury, illness, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, they may experience or incur in connection with attendance at the Academy or participation in Academy programming (“Claims”). Applicants hereby release, covenant not to sue, discharge, and hold harmless the Academy, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs, or expenses of any kind arising out of or relating thereto. By signing below, applicants acknowledge, understand and agree that this release includes any Claims based on the actions, omissions, or negligence

of the Academy, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Academy program.
